Written Test : The Candidates applying for the posts of Technical Officer (C) and Scientific Asst-A (C) has to download (print) **two copies of hall ticket** from our website and affix his / her latest colour photo (4 X 3 cms size) on both copies as and when the same is provided on our website. One copy of the hall ticket should be submitted to the Invigilator at Examination Centre. The other copy (hall ticket) can be retained by the candidate for future reference. Both the copies of hall tickets are to be attested (over the photo) by the Invigilator. The candidates will not be allowed for written test, in case of non-submission of 2 sets of Hall Tickets to Invigilator at the examination Centre.
