2. The interested employees of ECIL who are meeting the norms as specified in the detailed Advertisement may apply through online, subject to fulfilling the following conditions:

- a. Should have completed ONE YEAR of service from the date of appointment/ promotion to the present grade.
- b. Should have completed SIX MONTHS period from earlier consideration for higher appointment.
- c. Internal employees are exempted from payment of Application Fee.
- d. Internal employees include only regular and Technical Officer on Contract [who are presently engaged on fixed tenure basis].

The interested and eligible INTERNAL EMPLOYEES are hereby informed to visit the website: <http://careers.ecil.co.in> and submit online application only after carefully going through the Advertisement placed on the website. Further, Technical Officers on Contract currently working with us are also exempted from payment of Application Fee. No manually filled up applications from Internal Employees/ Contract Employees [who are presently engaged on fixed tenure basis] will be accepted. After online registration process, the employee should take a print-out of submitted online application submit to concerned Personnel Executive along with all the requisite enclosures i.e. GATE-2018 / 2019 Admit Cards, proof of Date of Birth, Educational Qualifications, Latest passport size photographs etc.

4. All Personnel Executives are informed to forward the applications with an endorsement of HoD/ GM/ZM to SDGM & In-Charge Recruitment on or before 11.01.2020. All eligible candidates should have appeared in GATE-2018 / GATE- 2019. The Internal Employees' Online Applications which are incomplete OR without requisite enclosures OR not routed through proper channel and not received before due date will not be considered.
